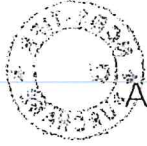

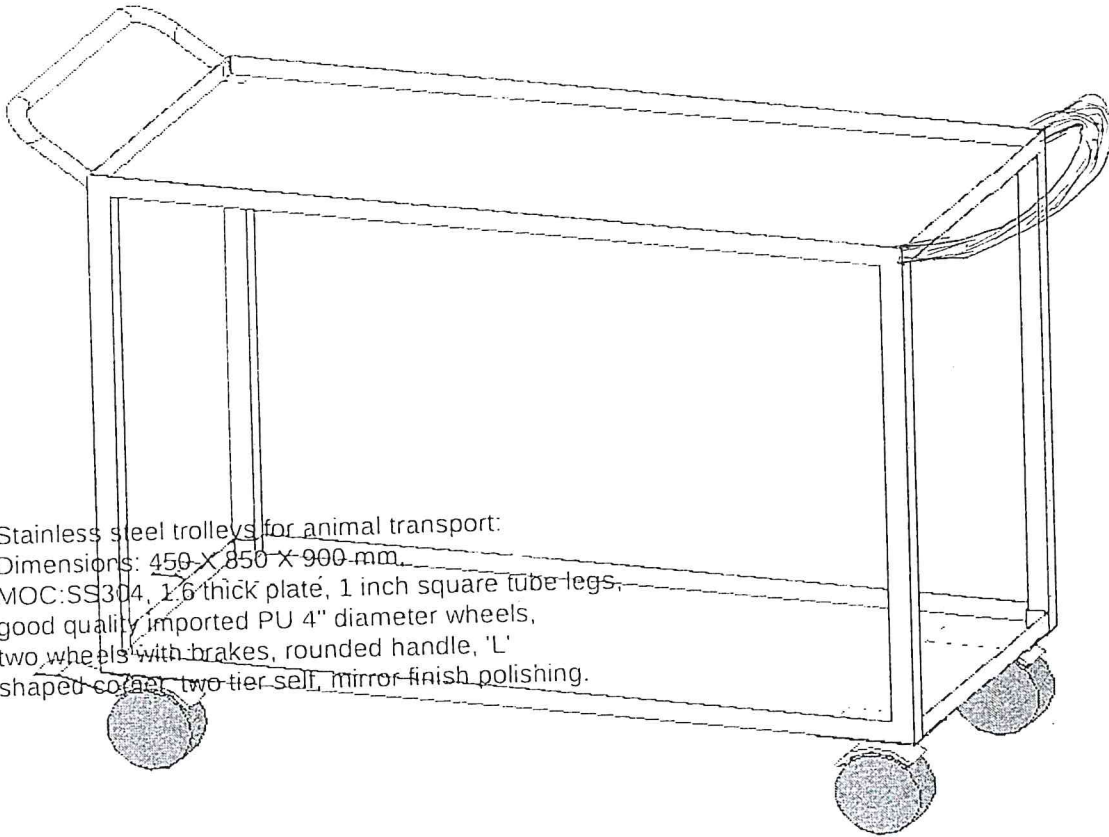

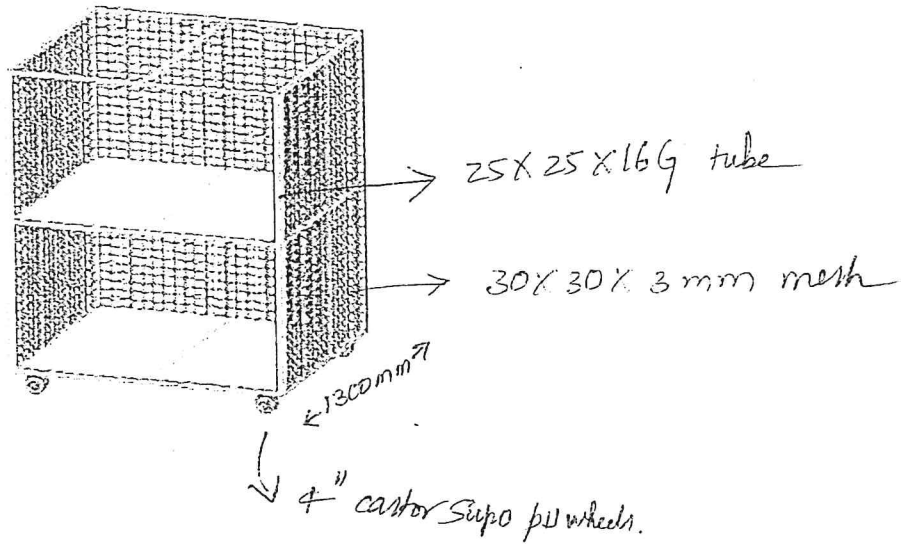


Animal Cage transport trolley
