1. System should have dual beam, and have wavelength range from 190nm to 1100nm.
2. System should have different measurement mode Absorbance, Transmittance
3. System should have Deuterium and Halogen Lamp
4. System should have predefined methods for nucleic acid purification assay, and cell culture density measurements
5. System should have Photo diode/ PMT detector
6. System wavelength accuracy should be $\pm 0.2\text{nm}$ (at 656.1nm)
7. System should have wavelength repeatability $\pm 0.1\text{nm}$.
8. System should have variable bandwidth from 0.1nm to 5nm
