/		1), We are looking for yeast cell disruption instrument that works at cryogenic temperatures (-185C). 2), The efficiency of cell lysts should be >75% 3), The batch size and volume (dry weight) should be at least 35 ml 4), The principle of lysis or reduction is impact or friction 5), We expect at least two grinding stations and the two grinding jars should be given with size of 125 ml and 50 ml and pressure tight up to 5 bar. 6), The vibrational frequency of milling should be at least 3 -35 Hz or more with typical grinding times of 30s -3 mins but maximum of 60 mins. 7).
