Rodent Maintenance Vegetal Diet - Irradiated at 25 kGy - 10 kg paper bag in hermetic plastic pouch.

Quantity -13,500 kgs.

Technical specification:

- 1). Complete maintenance diet for high SPF health status colony of Laboratory Mice and Rats.
- 2). It should not contain any Alfalfa and any animal ingredients.
- 3). 15 mm diameter pelleted formulation.
- 4). Package in 10 Kgs double bags, with paper bag in outer hermetic plastic pouch.
- 5). Gama irradiated at irradiation dose of more than 25 kiloGrays.
- 6). Required composition is Barley, wheat, maize, soybean meal, wheat bran, wheat germ, calcium carbonate, pre-mixture of minerals, pre-mixture of vitamins, dicalcium phosphate, lysine. Cereals and cerealsbio products-80.6%, Vitamin and mineral mixture-3.6% and Vegetable proteins-15.8%.
- 7). Should have nutritional composition: Proteins -15.2%, Cellulose -4.1%, NFE -61%, Moisture -12.1%, Lipids -3.2% and Minerals ash -4.4%
- 8). Every batch of feed must come with complete analysis report.
- 9). Shelf life of the rodent diet must be not less than a year from the date of manufacturing.
- 10) The prices includes Customs Clearance charges and truck charges from ICD Bangalore to NCBS. Customs Duty and DO charges will be paid by NCBS. Arranging clearance and other formalities of AQCS as well as any inspection/checking and test certificate costs for the feed if any shall be borne by the supplier.
