- 5. All duties, taxes, surcharge and cess as currently applicable must be stated in yourquotation, separately. Otherwise your quote is liable to be rejected.
- Your quotation should indicate delivery period & warranty period.
- 7. Delivery to be made to our stores. Please indicate charges, if any extra. Transit Insurance should be done upto NCBS Stores.
- 8.ff you are unable to supply the quality, specifications or brand as mentioned in our enquiry, please state so and then offer alternative to quality/specifications.
- 9.Payment: within one month after delivery & acceptance/satisfactory installation.

- 11. Since we are a public funded research institution, we are exempted from paying Customs duty (Except advolerum duty of 5% + 2%Cess and 1% Cus Sec & High Edu. CESS vide Notification No.51/96 with latest amendments) and excise duty vide Notification No. 10/97 CENTRAL EXCISE dated 01-03-1997 for all scientific equipments, technical instruments, equipments (including computers), their accessories, spares, consumables and software. - 12. If the item is covered under DGS&D rate contract, please quote the rate as per the DGS&D rate contract with xerox copy of the DGS&D order.

- 13. Any dispute or differences that may arise between the parties shall be referred to the sole arbitration of the Centre Director or his nominees. The decision of the arbitrator shall be final and binding on the parties. The venue for arbitration shall be Bangalore. The provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time shall apply. The courts in Bangalore shall have exclusive jurisdiction to deal with any or all disputes between the parties.
- 14. TIFR is a public funded research institute and is entitled to concessional rate of GST @ 5% for certain items supplied for reresearch purpose vide notification no. 47/2017 and 45/2017 dated 14th Nov. 2017. The offer should be submitted after fully considering the above notification.

SCOPE OF WORK & TERMS AND CONDITIONS:-

The contract shall cover the following:-

- 1. To provide EECO Vehicle (2018 and above model) with GPRS Facility as Ambulance on hiring (monthly basis)
- 2. The Vehicle should be equipped with Stretcher, Medical Oxygen Cylinders and Accessories, First Aid Kit.
- 3. Maintain the Ambulance including Fuel and if the vehicle goes for warranty services or repairs a similar back up vehicle should be provided.
- 4. Regular Service of Vehicles has to be taken care
- 5. Maximum usage Kilometers in a month will be upto 400Km.
- 6. The monthly charges agreed upon will include:
 - (a) Drivers Salary and Allowances
 - (b) Tax
 - (c) Fuel and Insurance
- 7. Penalty Clause: If Drivers / Vehicles do not report on time, it would attract the penalty clause.
- 8. Termination: The Contract could be terminated by either side by giving one month's Notice in writing.
- 9. The drivers shall be well trained, experienced with a valid license for driving public vehicles. The drivers shall be well mannered and polite and they should in addition to local languages know English or Hindi. They shall be well dressed in uniforms (to be provided by the successful bidders). All the drivers shall carry Mobiles for effective communication purposes.
- 10. You must notify to NCBS the names of the Employees normally engaged by you for providing the services referred to herein. It is normally understood and agreed between both the parties that we will not be responsible or be liable for any laws that are in force/that may come into force from time to time in respect of personnel engaged by you and you will be solely responsible for the terms and conditions of services, safety, etc.
- 11. It is understood and agreed that you will be held responsible for any disciplinary matters arising out of your Employees and you will take appropriate disciplinary action against those that might come into force from time to time in respect of personnel engaged by you and you will be solely responsible for the terms and conditions of services, safety, etc. You will be solely responsible to comply with all legal and statutory requirements that may arise out of this contract and in respect of the Employees engaged by you in fulfillment of the contractual obligations stated herein.
- 12. You will undertake to replace any Employee found to be unfit in any manner immediately.
- 13. It is clearly understood and agreed upon that either yourself or your Employees will not have any claim on Employment with NCBS at any point of time and this arrangement is purely an agreement between you and the Centre for rendering of services for the time specified herein.
- 14. The drivers need to obey the instructions given by the Incharge.
- 15. If the drivers have any problems, it only need to be sorted with the Incharge and no explanation will be accepted from the drivers as excuses for non-compliance of the orders.
- 16. When the drivers go for lunch or tea, they need to inform at reception as well as security at main gate and take the permission.
- 17. The Drivers should have the basic knowledge on First Aid and ABC resuscitation in case of medical emergencies.
